CREW Project: NRG-III Meeting

World Competition Day Celebrations

CUTS Accra, Ghana organised a Policy Roundtable discussion on the theme, 'Competition Issues in Public Procurement' on December 03, 2014 to complement the 'World Competition Day' celebrations globally. CUTS Accra appealed to the Government of Ghana and the Ministry of Trade and Industry to make the passage of the Competition Policy and Law a legislative agenda for 2015.

NEW PROJECTS

Advocating for a Functional Competition Regime/Framework

CUTS Accra, Ghana with funding support from the Business Advocacy Challenge (BUSAC) Fund is implementing a project entitled 'Advocating for a Functional Competition Regime/Framework', referred to as the (COMPAD). The main objective of the project is to advocate a well-enforced competition regime in Ghana. CUTS Accra is certain that a national competition regime in the country will reduce the uncertainty for businesses, as well as, serve as an important element of a regulatory package for private sector development. The project will be implemented over a period of 15 month.

Integrating Consumers' Voice in the Regional Integration Process

CUTS Accra, Ghana with funding support from the Support to West African Regional Integration Programme (SWARIP) is implementing a project entitled "Integrating Consumers' Voice in the Regional Integration Process: A Pilot in Select West African Countries". The main objective of the project is to assess the prevailing state of engagement of consumer groups/civil society in the issue of regional integration in select West African countries. Additionally, it is to lobby national and regional institutions to take account of consumer interests in regional integration process. The project will be implemented over a six-month period and it is scheduled to begin in October of 2014. The Department for International Development (DFID) funds SWARIP.

CUTS Accra, Ghana in the first quarter of the year 2015 will organise a sensitisation workshop, to share the research findings from data obtained in the field with all relevant stakeholders involved in the Competition and Advocacy (COMPAD) project for advocating for a functional competition regime in Ghana.

Briefing Paper

Why are Sugar Prices so High in Zambia?

Aquick review of studies undertaken by CUTS Lusaka confirms that sugar prices in Zambia are relatively high despite the fact that production costs are comparatively low. A recent Africa Competition Forum (ACF) report (2014) establishes that the prices of sugar in Zambia do not reflect the cost advantages and high-levels of productivity in that market. Moreover, a need was felt to identify main drivers for high sugar prices to be able to map strategies that are needed to bring them down. It is also important to establish the impact that the high sugar prices have on consumers as well as downstream manufacturing businesses that use sugar. Conclusively, it would be necessary to ascertain whether the high sugar prices have an impact on investment and employment. Understanding such issues would be critical in crafting policy recommendations to the government on how the problem could be solved.

Kisumu Citizen Report Card on Health Services

Over seven percent of Kisumu County residents have confirmed having engaged in bribery to secure health services at public health facilities. This is according to a study focussing on consumer feedback on health service provision that was launched in July 2013 by a non-governmental organisation, CUTS Nairobi, Kenya under the project 'Empowering Marginalised Community Groups for Inclusive Governance' in Kenya's Health Service Delivery (EMACIGHES). CUTS Nairobi Programme Officer In-charge of Consumer Protection and Governance, Daniel Asher mentioned that a majority of respondents paid Shs. 100 for while 20 percent paid Shs. 500 as bribes

Fuel Price Cut Minimal

Times of Zambia, 03 December, 2014

Local consumer rights groups have said the marginal decrease in fuel prices announced by the Energy Regulation Board (ERB) is negligible. But the Government has defended that the decision by ERB describing it as logical owing to the costs incurred in the procurement process of petroleum. ERB announced that fuel price reduction in the previous week following the plummeting crude oil prices on the international market.

The uniform pump prices per litre for petrol decreased to K10.38 from K10.63 per litre, diesel reduced to K9.73 from K10.01 per litre and kerosene was pegged at K7.21 from K7.48, per litre. CUTS International, Lusaka, Zambia Centre Coordinator Simon Ng'ona said that the decrease in the pump price of petroleum did not correspond to market forces locally and internationally.

CUTS for Synergies on Consumer Welfare

CUTS International, Lusaka, Zambia said that there is need for consumer-producer synergies for sustainable improvement in consumer welfare in the country. CUTS Board Member Yusuf Dodia said addressing anti-competitive practices in public procurement processes that impaired the envisaged outcomes of development was one way of promoting good governance of public resources.

Dodia said competition law was a panacea to addressing some of the public procurement challenges and, therefore, it was important that right resources were leveraged towards implementation of competition law. He said this at a competition and consumer protection commission (CCPC) meeting to commemorate world competition day in Lusaka. The CCPC also mentioned that the government procurement authorities should formulate strategies aiming at detecting anti-competitive practices and unusual schemes in the bidding processes.

Contracts in Africa are Shrouded in Corruption

It is estimated that 70 percent of contracts in the public sector are shrouded in corruption, which inevitably leads to a rise in 20 to 30 percent of the total contract sum. Globally, about USS400bn changes hands per annum through corruption in public procurement around the world.

Appiah Adomako, Executive Director, CUTS Accra, Ghana, made this known during the celebration of the 'World Competition Day', which is aimed at raising awareness about competition in awarding of contract. He noted that competition is a fundamental tenet of well-functioning markets, which encourage companies to provide consumers with the products and services that they want.
